Sl. No.	The school is directed to ensure that:	
1	The number of sections of Bal-Vatika shall be restricted to 9 (Three sections each in Bal Vatika I, II & III respectively) and total number of section of the school shall be restricted to 32 from class I to XII of which not more than 1/3rd sections may be used for senior secondary classes. The optimum number of the students shall be restricted to 40 in each section. Further, increase of sections shall be subject to specific approval of the Board on the basis of the request of the school as per affiliation by law and availability of class rooms of greater than 500 sq ft dimension.	
2	Safety features such as fire extinguisher are required to be installed in composite science lab, Physics and Biology Labs. All science labs does not have the sufficient number of Exhaust fans (minimum two as per SoP). School shall upgrade the labs in the light of SoP issued by the Board within 03 months and submit the compliance.	
3	Few of the CwSN Toilets are narrow and the space to navigate the wheelchair is not available and the gate is opening inside the cubicle which make is more difficult. School shall install slide door for easy movement of the wheelchair and walker while opening the gate to avoid difficulty to the CwSN or make the provision of any other specious CwSN Toilet within 03 months and submit the compliance.	

The school shall ensure the mandatory training of its teachers with CoE, CBSE, Pune 4 within 03 months and submit the compliance.

Compliance of the above mentioned points shall be submitted within 03 months on the SARAS Portal. Failure to comply within the prescribed time shall invite financial penalty @ Rs. 50,000/- every month until compliance is submitted and shall debar the school from filling the registration and LOC of students class IX to class XII, as the case may be.
